Child protection is a part of safeguarding and promoting welfare. This refers to the activity which is undertaken to protect specific children who are suffering or are at risk of suffering significant harm as a result of abuse or neglect.

EVERYONE has a responsibility for child protection at Ysgol Dyffryn Dulas and Ysgol Pennal Federation – pupils, staff, visitors and parents.

Everyone who works with children and young people should make sure children are safe from harm and take action if they have concerns.

If you have any concerns, or want to report an incident, these are the designated child protection officers/responsible adults on each site

Beth i'w wneud

- Gwrando heb ragfarn.
- Gofynnwch gwestiynau agored i gadarnhau ond nid i ymchwilio.
- Cysurwch y disgybl ond mae'n bwysig osgoi cyswilt ffisegol.

**Diffiniadau o gamdrin ac esgeuluso plant**

Gall rhywun gamdrin neu esgeuluso plentyn drwy beri niwed iddo, neu drwy fethu gweithredu i atal niwed.

Gall plentyn neu berson ifanc hyd at 18 oed ddioddef camdriniaeth neu esgeulustod a bod angen eu hamddiffyn drwy Cynllun Amddiffyn Plant Rhyngasiantaethol Gwynedd.

**Camdrin corfforol** – taro, ysgwyd, taflu, gwenwyno, llosgi neu sgaldio, boddi, mygu neu achosi niwed corfforol mewn unrhyw ffordd arall i blentyn (gall niwed corfforol hefyd gael ei achosi pan fydd rhiant neu ofalydd yn ffugio sumptomau iechyd).

**Camdrin emosiynol** – trin plentyn yn wael yn barhaus sy'n achosi effeithiau drwg difrifol a pharhaus i ddatblygiad emosiynol plentyn neu thrais yn y cartref.

**Camdrin rhywiol** – gorfodi plentyn neu berson ifanc i gymryd rhan mewn gweithrediad rhywiol, p'un ai yw'r plentyn yn ymwybodol o'r hyn sy'n digwydd ai peidio.

**Esgeulustod** – methiant parhaus i gyfarfod ag anghenion corfforol a/neu seicolegol sylfaenol plentyn.

### Record

- Seek advice as to what to do next.
- Avoid prejudice and voicing an opinion.
- Keep in touch with the child in order to provide support.
- Act in a professional manner, don't openly discuss the matter.
- Record what the child has said—in the child's own words.
- Note the context, time and date on your record and remember to sign it.

**“All members of staff at this school are well placed to observe external indications that suggest that a child is at risk of suffering significant harm”.**

*You may be involved in this process as you have ...*

- Noticed that a child has physical injuries that cannot be explained.
- A child may inform you what has happened to him or her.
- Another child may voice concern about another child's well-being.
- You may have observed a major deterioration in a pupil's performance at school.

*What action to take*

- Immediately notify the school's child protection contact.
- Don't pledge confidentiality—explain that you may have to talk with somebody else.
- Listen without prejudice.
- Ask open questions in order to obtain confirmation but not for investigative purposes.
- Console the pupil but avoid physical contact.

### DEFINITION OF MISTREATING AND NEGLECT OF CHILDREN

**Physical Abuse** – hitting, shaking, throwing, poisoning, burning or scalding, drowning, choking or causing physical harm in any way to another child (physical harm can also be caused when a parent or carer fakes health symptoms).

**Emotional Abuse** – continually treating a child badly which causes serious and continuous effects to the emotional development of the child or abuse in the home.

**Sexual Abuse** – forcing a child or young person to take part in a sexual activity, if the child is aware or not of what is happening.

**Neglect** – continuous failure to meet the physical and/or basic psychological needs of a child.

**Radicalisation** Radicalisation is the way some people come to support terrorism and violent extremism and even join terrorist groups. Signs that a child or young person is at risk of radicalisation include:

- changes in friendships, behaviour and language
- expressing extreme views
- having extremist type literature
- advocating violence
- associating with known extremists
